### Fair Credit Report Act – Section 606 (A), Effective April 25, 1971

Under the provisions of 15 U.S.C. §1681d(b), applicants may submit a written request to the Arkansas Racing Commission within a reasonable period of time after filing a partnership application for a complete and accurate disclosure of the nature and scope of the Commission's investigation. Under the provisions of 15 U.S.C. §§1681d(a)(1) and 1681g(c), applicants are entitled to receive a summary of their rights under the federal *Fair Credit Reporting Act* from a consumer reporting agency upon request to the agency.
